Instructions and Guidelines for Circulating and Signing Mike Flynn Petitions for Congress

Circulating petitions is easy and fun. You can circulate among your neighbors, at your business, within community and social groups, or any place that people gather. When you are done circulating, please contact us by phone or email below and we will arrange to get your signed and notarized petitions by **Sunday, April 19th**.

Circulators

Any citizen over the age of 18 can circulate a petition, even if they don't live in the district or even the state.

The circulator must witness each signature on the petition that he or she distributes.

You can copy a blank petition or print out additional ones.

You may distribute as many petitions as you'd like.

Your petition must be notarized to be valid. You must fill in your address on the circulator's statement.

An invalid signature does not invalidate all the other signatures on the petition. Petitions do not need to have every line filled in to be valid. Please turn in any partial petitions.

Do not number the petitions that you hand in.

Petition Signers

Anyone can sign who is a registered voter in the 18th Congressional District. A person who has signed a Democratic petition for the special election is ineligible to sign this petition, however there are no announced Democratic candidates so that shouldn't be an issue.

A person can sign a petition for more than one Republican candidate for the 18th Congressional District vacancy.

Signers and circulators must give a valid physical address on the petition. No post office boxes are allowed.

Petitions should be signed as the person signs his or her name typically.

You may sign the petition that you are circulating.
