RE: OMA Request for Review – 2017 PAC 48494

Dear Ms. Hamilton:

The Public Access Bureau has received a Request for Review in which Ms. Diane Benjamin alleges the Bloomington Public Library (Library) Board of Trustees (Board) violated the Open Meetings Act (OMA) (5 ILCS 120/1 et seq. (West 2016)). A copy of the Request for Review is enclosed.

In her Request for Review, Ms. Benjamin alleges that the Board held meetings on June 19, 2017, and June 20, 2017, without posting advance notice on the Library's website for either meeting. We construe Ms. Benjamin's Request for Review as alleging violations of section 2.02(a) of OMA (5 ILCS 120/2.02(a) (West 2014)). We have determined that further inquiry is warranted.

To further evaluate this matter, we request that the Library or its representative provide a written response to the allegations in the Request for Review. In your response, please address whether the Library held meetings on June 19 and June 20, 2017; and if so, please specify if and when notice was posted on the Library's website. Additionally, please clarify whether the Library's website is maintained by a full-time staff member. Also, please provide copies of the meeting notice, agenda, and minutes (draft form if necessary) for both the June 19, 2017, meeting and the June 20, 2017 meeting.

As required by section 3.5(b) of the Open Meetings Act (5 ILCS 120/3.5(b) (West 2016)) please provide this information to our office within 7 working days after receipt of this letter. As we conduct our review of this matter, we will notify you if we need to

review additional records or information. You have the option under the Act to provide a written response to these allegations in addition to the requested materials. That response may take the form of a letter, brief or memorandum. Please note that under the Act, we are required to forward a copy of any response from a public body to the requester and provide the requester an opportunity to reply. 5 ILCS 120/3.5(c) (West 2016). The Act also permits a public body to provide a copy of a response with confidential information redacted for release to the requester. If you claim that any portion of your written response is confidential, please send two versions of your response letter: a complete copy for this office's confidential review and a redacted version suitable for this office to forward to the requester. If you believe that other documents or information would be helpful to us as we review the issues, you may submit additional records or affidavits.

Please advise.


