#### Dear AAG Cook:

The Town of Normal has received a Request for Review for 2018 PAC 51301. This Request for Review is about the adequacy of the notice of the Town Council's budget discussions,

Diane Benjamin alleges that members of the Town Council met to discuss public business without providing proper notice of the meeting. Benjamin is right about the meeting; she is wrong about the notice.

On January 18, 2018, members of the Council held a workshop to discuss the Town budget. All seven Councilmembers attended. The workshop was for discussion purposes only. The Council took no final actions, nor did it conduct any formal business. No votes were taken. No quorum was required for the discussions, and no roll call was taken.

Because the workshop would involve at least a majority of a quorum, the Town posted notice both at City Hall, where the workshop occurred and on the Town's website. The notice included the time, place, and date of the workshop. It also included item that it was a budget discussion workshop. The notice was placed in both locations on November 29, 2017, well in excess of the Open Meetings Act's notice requirement.

Because there was no business conducted, there was no agenda other than
the general description of the topic of discussion included on the notice.

The statute requires notice be given at least 48 hours before the meeting.
 5 ILCS 120/2.02. The Town provided notice about 1,200 hours before the meeting.

The physical notice was placed in the glass case at City Hall, where all Town meeting notices are located. The web-site notice was included in the schedule of events, located on the front page of the Town's website.

The workshop was open to the public, held from the hours of noon-6pm on a Thursday, and held at City Hall. The time and place were open and convenient, as required under \$2.01 of the Open Meetings Act.

In response to the Town's notice, members of the press and members of the public attended. In fact, from her request for review, it appears that Ms. Benjamin heard about the budget workshop from a story by a reporter who attended. The meeting was hardly covert.

The Town gave sufficient notice of the meeting. Enclosed are copies of the notices that the Town produced. If you have any additional questions on this matter, please contact me at 309-454-9507 or at bday@normal.org.
