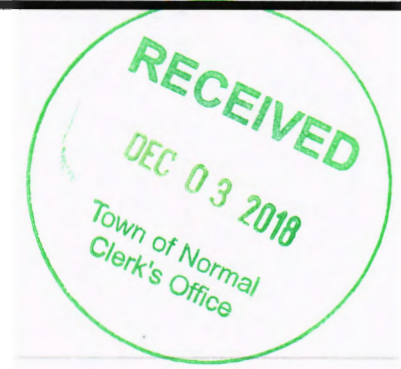



Reporting OFFICER JONATHAN MCCAULEY - NPD, ID # 7796

On 01/09/18, at approximately 15:45 hours, Officer Benner was dispatched to the intersection of N. Main Street and W. Raab Road for a report of an intoxicated driver. Metcom advised that a white Chevrolet pickup truck bearing Illinois registration [REDACTED] was traveling southbound on N. Main Street and was "swerving all over the road". The white Chevrolet pickup was further reported "driving really slow" and "crossing over lines" as it proceeded southbound on N. Main Street near the Illinois State University Stadium.

At approximately 15:56 hours, Officer Benner located the white Chevrolet pickup truck bearing Illinois registration [REDACTED] traveling eastbound on W. College Avenue from N. Main Street. Officer Benner however was unable to catch up to the vehicle to effect a stop due to other traffic on the roadway. When Officer Benner was unable to catch up to the vehicle he provided other Normal Officers the direction of travel for the vehicle.

Based on Officer Benner's radio transmission, I traveled to the intersection of S. Walnut Street at E. College Avenue and waited for the white Chevrolet pickup truck to pass. When I observed the white Chevrolet pickup truck bearing Illinois registration [REDACTED] pass the intersection I pulled onto E. College Avenue and caught up to the vehicle. Once I was behind the vehicle and there were no vehicles obstructing my view I began to monitor the vehicle for any possible lane violations as described during the initial call for service.

In the 600 block of E. College Avenue I observed the white Chevrolet pickup truck commit a lane violation. When the white Chevrolet pickup truck committed the lane violation it did so by drifting from the right lane partially into the left lane. The two drivers side tires on the white Chevrolet pickup truck, when the vehicle drifted from the right lane into the left lane, crossed over the white dashed lane line.

After observing the lane violation I prepared to initiate a traffic stop on the white Chevrolet pickup truck. Prior to conducted a traffic stop on the vehicle however the white Chevrolet pickup truck committed an additional lane violation. In approximately the 1000 block of E. College Avenue the white Chevrolet pickup truck again drifted from the right lane partially into the left lane. The two drivers side tires on the white Chevrolet pickup truck, when the vehicle drifted from the right lane into the left lane, crossed over the white dashed lane line.

Upon observing the second lane violation I notified Metcom of the traffic stop and activated the squad cars emergency lights to stop the vehicle. The white Chevrolet pickup truck did not immediately stop however and continued on E. College Avenue until it reached the intersection of E. College Avenue at S. Blair Drive. At the intersection of E. College Avenue at S. Blair Drive the white Chevrolet pickup truck turned southbound and came to a stop just prior to Westview Drive.

Once the vehicle came to a stop I approached on the driver's side window and made contact with the driver, later identified as SHANE STORK. After greeting Shane I identified myself and informed him the reason for the stop. Shane advised he understood and I began to speak with him and [REDACTED]. I learned via my conversation with Shane and [REDACTED] that [REDACTED]

After making initial contact with Shane I noted that during my conversation with him I could smell a strong odor of an alcoholic beverage and observed him to display other indicators of impairment. The other indicators of impairment I observed during my initial contact included glassy and bloodshot eyes as well as thick tongued speech.

Once I confirmed that Shane had a valid driver's license I reproached the vehicle and requested Shane exit. Prior to Shane exiting the vehicle I requested he make sure the windows to his white Chevrolet pickup truck were up as to ensure [REDACTED] stayed warm.

After Shane had exited the vehicle I ensured he did not possess any weapons, via consent to pat down his person. From Shane's person I recovered a pocket knife. The pocket knife was secured on my person for the remainder of the investigation and Shane has been advised it is available for him to recover from the Normal Police Department. With Shane no longer in possession of any weapons I spoke with him about his consumption of alcohol. Shane advised [REDACTED]

Once I had spoken to Shane about his consumption of alcohol I asked him to perform standardized field sobriety testing. Shane consented to performing the standardized field sobriety testing.

Shane was provided instructions for Horizontal Gaze Nystagmus and once I confirmed Shane understood the directions to the test it was conducted.

I observed the following during Horizontal Gaze Nystagmus:

Shane displayed equal tracking and pupil size in both eyes.

1. Shane displayed lack of smooth pursuit in both his left and right eye.
2. Shane displayed distinct and sustained nystagmus at maximum deviation in both his left and right eye.
3. Shane displayed nystagmus onset prior to 45 degrees in both his left and right eye.

It should be noted that while administering HGN I could smell again the odor of an alcoholic beverage as Shane exhaled. I also observed Shane to sway in multiple directions as he stood heel and toes together.

After completing HGN and after being provided directions for the walk and turn test I discussed with Shane any medical conditions that would impact his performance on the next two standardized field sobriety tests. Shane advised he had no medical conditions that would impact his performance on Standardized Field Sobriety Test.

Once Shane had provided information as to what medical conditions would impact his performance on SFSTs I confirmed he had no questions and he began the test. It should be noted that the walk and turn test was demonstrated to Shane in its entirety.

The following are my observation of Shane during the walk and turn test:

1. Shane was unable to maintain the start position when he was placed in it after the instructions had been provided.
2. Shane missed heel to toe on steps 1, 2, 3, 4, 5, 6, 7, 8, and 9 of the first nine step sequence.
3. Shane took twelve steps during the first nine step sequence.
4. Shane raised his arms during the first nine step sequence in order to maintain his balance.
5. Shane came to a stop after taking twelve steps during the first nine step sequence.

The walk and turn test was concluded after Shane came to a stop after taking twelve steps during the first nine step sequence. Shane walked from the start position into the back of his white Chevrolet pickup truck and after doing so turned to look at me. I requested Shane walk back with me to an area in front of the camera so we could perform the one leg stand test.

The following are my observations of Shane during the one leg stand test.

1. Shane dropped his foot three times while attempting to balance.
2. Shane raised his arms in an attempt to maintain his balance.
3. Shane swayed until he began to fall over.

The one leg stand test was ended after Shane began to fall over in order to mitigate the risk of injuries.

Shane at the conclusion of the one leg stand test was placed in custody for driving under the influence of alcohol. Shane was secured in handcuffs, checking for fit and double lock. Shane was searched incident to arrest with no items of contraband being located on his person.

Shane was transported to the Normal Police Department for further processing. Officer Benner remained on scene with [REDACTED] until her mother Jennifer Stork arrived to take custody of her.

At the Normal Police Department Shane was issued a traffic citation for 625 ILCS 5/11-501(a)(2). After Shane was issued the traffic citations I filled out the Warning to Motorist, began the 20 minute observation period, and read him the Warning to Motorist. The 20 minute observation period was began at 16:43 hours. Once the Warning to Motorist was read and I confirmed Shane had no questions he, Shane, signed it.

At approximately 17:10 hours, Shane submitted a breath sample. Shane's breath alcohol concentration was .226. After Shane submitted a breath alcohol concentration over a .08 he was issued a traffic citation for 625 ILCS 5/11-501(a)(1) and the law enforcement sworn report was completed. Shane was read the law enforcement sworn report and his receipt to drive was signed.

Shane declined to be interviewed under Miranda and was provided copies of all necessary paperwork. Shane was transported to Mclean County Jail. During the transport Shane was secured in two sets of handcuffs, checking for fit and double lock. Shane was issued a total of four traffic citations.

Officer Benner completed an inventory of Shane's vehicle and filled out a tow sheet per policy. A tow hearing date was set for 02/13/18. Joe's towed the vehicle to their secure lot. Shane was provided with a tow hearing notice as part of his paperwork.

This case should be cleared by the adult arrest of Shane Stork.
