OBJECTION TO DEFENDANT'S REQUEST TO EXPUNGE & IMPOUND AND/OR SEAL CRIMINAL RECORDS

Now come the People of the State of Illinois by Bradly Rigdon, Assistant State's Attorney, and object to the Defendant's Request to Expunge & Impound and/or Seal Criminal Records and in support thereof state as follows:

Procedural Posture

- 1. The Defendant filed a Request to Expunge & Impound and/or Seal Criminal Records in the above-entitled case.
- 2. On August 25, 2020, the Defendant entered into a fully-negotiated plea agreement in the above-entitled matter.
- 3. That, in the above-entitled case, multiple charges against the Defendant were dismissed subject to a fully negotiated plea to Count 45, the Class A misdemeanor offense of Theft. A plea agreement in McLean County Case 2020-CF-0859 occurred as well as the link between the two pleas is documented within the plea paperwork in each file. The State requests that the Court take Judicial Notice of the file in 2017-CF-1025 and in 2020-CF-0859.
- 4. The terms of the plea agreement in McLean County Case 2017-CF-1025 are documented in plea paperwork.
 - a. The agreement as it pertains to 2017-CF-1025 resulted in a plea of guilty and entry of a conviction against the Defendant for the Class A misdemeanor offense of Theft in Count 45. The Defendant agreed to serve 91 days of home confinement and pay restitution in the amount of

- \$430,230.00 to the City of Bloomington and \$19,770.00 to the Illinois Department of Revenue.
- b. Additionally, the Defendant's company, BMI Concessions, L.L.C. accepted criminal liability and pled to the Class 1 felony offense of Theft in McLean County Case 2020-CF-0859. Specially, within the Manager's Certificate, the Defendant affirmed his agreement to the terms of the plea and acknowledged his role within that organization. the plea agreement form.
- 5. On August 23, 2021, the Defendant filed a document entitled "Request to Expunge & Impound and/or Seal Criminal Records" and asks that the Court expunge and seal the records relating to the above-entitled matter.
- 6. An October 26, 2021 deadline was set by which any objections to that request must be filed.

Statement of Law

- 7. The standard for the expungement and sealing of records is controlled by 20 ILCS 2630/5.2 *et seq*.
- 8. An individual may expunge records of his arrest and charges when each arrest and charge resulted in a dismissal of the charges, a conviction was vacated, the sentence imposed was that of court supervision, or the sentence imposed was that of a qualified probation. 20 Ill. Comp. Stat. Ann. 2630/5.2(b)(1).
- 9. An individual may seal records of arrests or charges under a variety of circumstances. When an individual's arrest or charges resulted in a conviction, said records may be sealed 3 years after termination of the petitioner's last sentence. *Id.* at (c)(3)(C).
 - a. "Last sentence" is defined within the statute and, in this instance, means the sentence that terminated last in time in any jurisdiction. *Id.* at (a)(1)(F).
 - b. That timeline may be changed if the petitioner completed certain educational requirements. *Id.* at (c)(3)(E).
- 10. Any objections to the entry of an order expunging or sealing must be in writing and must state the basis of the objection with specificity. *Id.* at (d)(5).

- a. An objection tied to the fact that the records contain relevant information beyond mere facts of the arrest is a consideration for the court and an independent ground for an objection to be filed. *Id.* at (b)(1.5).
- b. The provisions allowing for the filing of the request to seal or expunge place the final decision within the direction of the Court. The provisions are not mandatory which allows the Court to determine the appropriateness of those requests on a case-by-case basis. 20 ILCS 2630/5.2 et seq.

Bases of Objection and Argument

- 11. The Defendant is not eligible to expunge the records in the above-entitled matter because a conviction was entered in Count 45 for the Class A misdemeanor offense of Theft.
 - a. The Defendant did not receive a dismissal or acquittal of all charges.
 - b. The Defendant was convicted of the offense and did not receive an order of Court Supervision.
 - c. The nature of the conviction entered against the Defendant did not result in an order for a term of qualified probation which would entitle him to request expungement.
- 12. The Defendant is not eligible to seal the records because it has not been at least 3 years since the termination of his last sentence.
- 13. Even if the Defendant is eligible to expunge or seal the records, the Court should still deny the request within the Court's discretion.
- 14. The underlying conduct of the Defendant that comprised the charges in McLean County Case 2017-CF-1025 included a very high volume of fraud, theft, and deception that deprived funds from the taxpayers of the City of Bloomington. The plea involved an acknowledgement of theft from the taxpayers and a dismissal of some of the charges in 2017-CF-1025; however, the Defendant was still convicted of the offense of Theft and BMI Concessions, L.L.C. was convicted of a felony offense of Theft based upon the conduct of that Defendant.

- 15. The statute for expungement is not designed to be a mechanism by which individuals can so aggressively violate the public trust and then have that conduct swept under the rug; this is the type of circumstance that mandates the existence, and use, of judicial discretion in the denial of a petition to expunge.
- 16. Unlike other types of dismissals, this is not a situation in which the Defendant was cleared of criminal conduct or determined not to have been engaged in the wrongdoing with which he was charged. He pled guilty and was convicted of theft from the taxpayers as part of the plea agreement.
- 17. Additionally, while many of the charges in the above-entitled matter were dismissed, they do contain relevant information aside from the mere fact of arrest. The proceedings and litigation conveyed details of the investigation and the conduct of the Defendant during his time with Central Illinois Arena Management. The ongoing investigation is what yielded the documents that showed initial evidence of the Defendant's criminal conduct alleged in 2018-CF-0759. Of particular note is that Central Illinois Arena Management as a corporate entity, John Butler, Jay Laesch, and Paul Grazar were all convicted of offenses that arose out of the records tied to the above-entitled matter. An order to expunge or seal the records would not be allowed to be entered in the other matters as those cases are not yet eligible for expungement. Pursuant to 20 ICS 2630/5.29(b)(1.5), an objection tied to the fact that the records contain relevant information beyond mere facts of the arrest is a consideration for the court and an independent ground for an objection to be filed.

WHEREFORE, the People of the State of Illinois respectfully request that the Defendant's Request to Expunge & Impound and/or Seal Criminal Records be denied and that a hearing on the Request be scheduled.



Effective January 1,2010, the Criminal Identification Act relating to expungement and sealing was rewritten and is now found at 20 ILCS 2630/5.2.

There are a number of significant changes that you should be made aware of.

- 1. Any objection to a petition for expungement or sealing must now be filed within 60 days of the date of service of the petition (the date indicated on the Proof of Service) pursuant to 20 ILCS 2630/5.2(d)(5). Any written objection must therefore be sent to the McLean County Circuit Clerk, P.O. Box 2420, Bloomington, IL 61702-2420, within 60 days of the date contained in the Proof of Service of the Notice of Filing of the petition.
- 2. If an objection is filed, the Act contemplates a hearing being held. Notice of such a hearing must be sent by the Clerk to all parties at least 30 days in advance of the hearing date. The Act does not contemplate a hearing absent the filing of an objection.
- 3. Following any order of expungement or sealing entered by the Court, any motion to vacate, modify, or reconsider must now be filed within 60 days of the date of entry of said order. Any written motion to vacate, modify, or reconsider must therefore be sent to the McLean County Circuit Clerk within 60 days of the date of the entry of a court order.
- 4. Cases involving a sentence of court supervision or a conviction for the offense of Reckless Driving will no longer be eligible for expungement or sealing.

Please refer any further questions or concerns to the McLean County Circuit Clerk or the Office of the State Appellate Defender Expungement Unit at expungement.osad.state.il.us or by telephone at (866)787-1776.

If no objection is filed before Tuesday, October 26, 2021, your file will be sent to the Judge for review. If an objection is filed you will receive a Notice of Hearing date which will require your appearance in court.
