



MOTION FOR SCHEDULING RELIEF

NOW COMES the Defendant, JOHN Y. BUTLER, by and through his attorneys, J. Steven Beckett of Beckett Law Office, P.C. and Tristan N. Bullington of Meyer Capel, P.C., and in support of his *Motion for Scheduling Relief* states as follows:

- I. Lack of Specificity as to State's Exhibit List
- 1. On July 9, 2020, this court granted Defendant's request to require the State and Defense counsel to exchange exhibit lists on or before August 5, 2020.
- 2. On August 5, 2020, the State tendered its Exhibit List to Defense Counsel. A true and accurate copy of the State's Exhibit List is attached hereto as Exhibit 1.
- 3. That Exhibit List identified an exhibit titled "Settlement workbooks for events where third-party concessions commissions were not included in commissions owed to the city (thumb drive)." Contemporaneously with tendering the Exhibit List, the State tendered to Defense Counsel a CD containing the referenced exhibit.
- 4. Upon examination of that CD, it was determined that this "settlement workbooks" exhibit is approximately 15,598 pages.
 - 5. Additionally, listed as exhibits, among others, on the State's Exhibit List are:
 - a. "Wire transfer"
 - b. "Data from Kelly Klein's Computer"

- c. "Data from Jay Laesch's Computer"
- d. "Data from thumb drive provided by Jay Laesch"
- e. "Cash sheets from events where cash was not properly reported"
- f. "Documents and emails pertaining to transition and negotiations regarding transition"
- g. "Sponsorship/suites contracts subject to commissions payment analysis"
- h. "Invoices and Bill Payment Forms for \$162,000"
- i. "Profit and Loss Statements"
- j. "MICROS reports from events where cash was not properly reported"
- k. "Email exchange and letters regarding Diane Benjamin Lawsuit/FOIA"
- 6. Defendant tendered an exhibit list with sufficient details to enable the State to identify specific documents that Defendant intends to use as exhibits. A true and accurate copy of Defendant's Exhibit List is attached hereto as Exhibit 2.
- 7. The State has failed to provide any specificity as to a large portion of their Exhibit List. Defendant is unable to identify specific documents upon which the State intends to rely.
- 8. Of the 15,598 pages of financial records that were tendered on a CD to Defendant, Defendant has absolutely no way of knowing which specific documents the State actually intends to reference at trial. Expecting Defendant to familiarize himself with all 15,598 pages of financial records four days before trial is unreasonable and places an undue burden on Defendant.
- 9. The State has failed to tender an appropriately detailed exhibit list. The State should identify which of these 15,598 pages it intends to rely upon. The State should identify with specificity which exhibits it intends to rely upon at trial so that Defendant can adequately prepare for trial.

WHEREFORE the Defendant, JOHN Y. BUTLER, prays that this Honorable Court order that the State: produce an appropriately detailed exhibit list so as to allow Defendant to identify specific exhibits upon which the State will rely; produce a detailed list of which of the 15,598 pages of the above-referenced CD that State intends to introduce as exhibits; produce this information on or before August 12, 2020; and for such other relief deemed just and appropriate.

II. Unfair Surprise as to Kelly Klein Application for Use Immunity

- 10. On August 4, 2020, the State filed an *Application for Order Authorizing Use Immunity* in which the State asked for an order compelling Kelly Klein to testify.
- 11. Kelly Klein was initially charged with the same conduct as Defendant in 2017. Her charges were dismissed in 2019 and never refiled by the State.
- 12. The State has been aware that Kelly Klein possessed information relating to Defendant's case since before they filed charges against Defendant or any of the co-defendants.
- 13. Defense Counsel has spoken to Kelly Klein's attorney on multiple occasions and was told each time that Kelly would not be testifying.
- 14. The State could have applied for use immunity for Kelly Klein at any point in the past three years and instead chose to wait until six days before the beginning of trial.
- 15. Due to personal reasons, Kelly Klein's attorney will be unavailable until August 17, 2020, and as such, Defense Counsel will not be afforded an opportunity to speak with Kelly Klein prior to the commencement of trial.
- 16. Because of the State's lack of adequate disclosure of necessary trial details, and the unnecessary delay in applying for the immunity for Kelly Klein, Defendant will suffer prejudice by not being prepared for the presentation of evidence and not being prepared for the cross examination of Kelly Klein due to an inability to interview the witness.

WHEREFORE the Defendant, JOHN Y. BUTLER, prays that this Honorable Court allow for jury selection to begin on August 10, 2020, immediately followed by the presentation of opening statements, but delay the beginning of the presentation of evidence until August 17, 2020, and for such other relief deemed just and appropriate.

III. Jury Issue Caused by Covid Related Adjustments

17. On August 6, 2020, it was brought to Defense Counsel's attention that Unit 5 and District

87 schools - the school systems for the Bloomington-Normal area - would be conducting all

classes remotely for the first semester.

18. This information significantly impacts the potential jury pool in that parents of school-aged

children will be much more likely to be struck for cause. This raises a concern that Defendant will

not receive a true cross-section of a jury of his peers.

19. However, if the selected jurors were given additional time to make arrangements for their

school-aged children after being impaneled as jurors, this potential issue can be cured and would

allow for a broader cross-section of the community to serve without issue.

WHEREFORE the Defendant, JOHN Y. BUTLER, prays that this Honorable Court allow

for jury selection to begin on August 10, 2020, immediately followed by the presentation of

opening statements, but delay the beginning of the presentation of evidence until August 17, 2020,

and for such other relief deemed just and appropriate.


