NOTICE OF INTENT TO OFFER EVIDENCE OF PRIOR BAD ACTS EVIDENCE

NOW COMES, the People of the State of Illinois, by Assistant State's Attorneys, Bradly Rigdon and Chris Spanos, for the Office of the State's Attorney of McLean County, Illinois, and pursuant to prior proceedings in this matter, provide notice of the State's intent to offer evidence of prior bad acts under Rule 404(b) of the Illinois Rules of Evidence, and states as follows:

- 1. That during the hearing on the Defendant's Motion in Limine conducted on March 6, 2020, the State informed the Court and counsel of no known prior bad acts that were intended to be utilized during the trial in this matter; however, the State reserved the right to alert the Court and counsel if such intent arose.
- 2. Rule 404(b) allows for the admission of other crimes, wrongs, or acts evidence at a trial when "[s]uch evidence may also be admissible for other purposes, such as proof of motive, opportunity, intent, preparation, plan, knowledge, identity, or absence of mistake or accident. IL R EVID Rule 404.
- 3. The scope of the admissibility of such evidence has been addressed in multiple cases. In *Kimbrough*, the court ran through a list, citing to numerous other matters, in its holding that "[t]hus, evidence of the commission of other crimes is admissible if it is relevant to

prove modus operandi, motive, knowledge, intent, absence of mistake or accident, defendant's state of mind, absence of an innocent frame of mind or the presence of criminal intent, circumstances or context of defendant's arrest, placement of defendant in proximity to the time and place of the crime, identification of the weapon used in the crime, consciousness of guilt, that the crime charged was part of a common design, scheme or plan of the defendant, circumstances of the crime charged that would otherwise be unclear, whether the crime charged was actually committed and opportunity or preparation." *People v. Kimbrough*, 138 Ill. App. 3d 481, 484–85, (1st Dist. 1985).

- 4. Through ongoing trial preparations, the State has determined that three areas of evidence presentation may fall under this section of the rules and notice of such intent is appropriate based upon the State's representations at the prior proceeding.
- 5. The areas in which the State intends to elicit evidence are:
 - a. The presence of a shredding truck and the destruction of documents in the final days that the Defendant's corporation, CIAM, occupied the U.S. Cellular Coliseum in 2016.
 - Said evidence will be elicited through the testimony of witnesses. During
 the course of the investigation, the Illinois State Police utilized subpoenas
 duces tecum, search warrants, and consent to obtain voluminous records.
 However, during the course of the investigation, an unknown number of
 documents relating to the billing and invoicing for events, catering, and
 other matters were not recovered. The shredding truck and destruction of
 documents were described by multiple individuals.

to be allowed.

- ii. Pursuant to Rule 404(b), the presence of that vehicle is evidence of intent to destroy documents which would show evidence of wrongdoing, the absence of mistake in the fact that they were never provided to investigators, as well as the plan and knowledge to ensure that the City of Bloomington did not get a full understanding as to the extent of the fraudulent conduct and theft committed by the Defendant and his codefendants.
- (b) The attempt to remove fixtures and equipment from the U.S. Cellular Coliseum prior to exiting the premises.
 - i. Multiple charges relate to the theft of funds through fraudulent billing and invoicing for cleaning equipment over a course of years.
 - ii. Pursuant to Rule 404(b), the attempt to remove equipment at that time shows the evidence of wrongdoing in that is provides further evidence of the intent, plan, preparation, and knowledge on the ongoing theft at the time of the exit from the facility and termination of the contract. It goes to show that there was an absence of mistake in billing practices related to equipment as well as the request for funds in the month priors to the time of the departure from the facility.
- C. Information relating to the prior audit and fine in 2010 levied against BMI Concessions by the Illinois Department of Revenue.
 - i. Pursuant to Rule 404(b), the prior sanction and the timing of the sanction provides further evidence of the intent, plan, preparation, knowledge, and motive behind the utilization of the "Kelly Discount" as a mechanism to

secretly withhold approximately \$34,000 in funds that should have been due and payable to the City of Bloomington. The audit and fine provide further evidence of the knowledge and absence of mistake as it relates to the appropriate utilization of sales tax exemption.

6. If, as trial preparations continue, the State becomes aware of additional information that fall into this category or plans to use additional evidence that falls into this category, the State will appropriately supplement this Notice.

WHEREFORE, the People of the State of Illinois respectfully request that the Court accept this notice of potential evidence, as ordered by prior ruling, for which the State may seek admission under Rule 404(b) and, if admission under that section is disputed, that a hearing be conducted to determine the admissibility of said evidence prior to the commencement of the trial in this matter.







MOTION TO RECONSIDER AND INCLUDED MEMORANDUM IN SUPPORT

THEREOF

NOW COMES the Defendant, JOHN Y. BUTLER, by and through his attorneys, J. Steven Beckett of Beckett Law Office, P.C. and Tristan Bullington of Meyer Capel, P.C., and in support of his *Motion to Reconsider* states as follows:

Factual Background

- On December 30, 2019, the Court made a finding that the Illinois State Police had exceeded
 the scope of the warrants to search and seize records located at the office of Striegel
 Knobloch and Defendant's ABC Storage unit.
- 2. On January 8, 2020, the Court entered an Agreed Order laying out the terms by which the State and Counsel for Defendant would meet in Pontiac, Illinois for the purpose of reviewing all the physical records seized pursuant to the two above-mentioned warrants and having the Defendant remove any out of scope records at his own cost.
- 3. The State and Counsel for Defendant met at the Illinois State Police headquarters in Pontiac, Illinois on January 29, 2020 and reviewed all records that were seized subject to the two warrants.

- 4. On January 29, 2020, Counsel for Defendant removed the entirety of the out of scope records that could be located.
- 5. The State is also in possession of electronically scanned copies of every single document that was seized pursuant to the ABC Storage and Striegel Knobloch warrants. These scans include electronic copies of all of the out of scope documents that were physically removed by Counsel for Defendant from Pontiac on January 29, 2020.
- 6. On January 30, 2020, Defendant filed a Motion To Return, Expunge, or Destroy All Electronic Copies of Out of Scope Pontiac Records asking the Court to order the State to return, expunge, or destroy all electronic copies of the illegally seized, out of scope documents.
- 7. On March 6, a hearing was held on Defendant's *Motion To Return*, *Expunge*, *or Destroy All Electronic Copies of Out of Scope Pontiac Records*. During this March 6th hearing, the State argued, for the first time, that they should be allowed to maintain copies of the illegally seized and out of scope records for use against the co-defendants. The Court denied Defendant's motion and allowed the State to maintain the illegally seized records

Argument

- I. Regardless of Whether the State Wishes to Use Illegally Obtained Evidence against a Co-Defendant, Defendant has a Right to have all Originals and Copies of His Possessions Returned.
- 8. If a motion to suppress illegally seized evidence is granted, "the property shall be restored, unless otherwise subject to lawful detention." *People v. Fratto*, 32 Ill.App.2d 354 (Ill. App. 1961); *People v. Ziomek*, 179 Ill.App.3d 303 (Ill. App. 1989). In Defendant's case, his *Motion to Suppress* was granted insofar as the State was ordered by the Court to return all out of scope documents that were seized pursuant to the ABC Storage and Striegel

Knobloch warrants. Defense Counsel has been unable to locate any authority which dictated that the fruits of an illegal seizure can be lawfully detained for use against other defendants.

- 9. The issue of needing the material for a co-defendant is a red herring, and is not relevant to whether the material seized outside the scope of the warrant must be returned to Defendant or destroyed.
- 10. Even if a co-defendant believed the material seized were relevant for their defense, the codefendant would have the Court's subpoena power available to obtain that material.
- 11. The government may not retain seized property indefinitely. *People v. McCavitt*, 2019 IL App (3d) 170830 (citing *United States v. Premises Known as 608 Taylor Avenue*, *Apartment 302*, *Pittsburgh*, *Pennsylvania*, 584 F.2d 1297, 1302 (3d Cir. 1978)). The Fourth amendment may be violated when the State fails to quickly return information . . . that is not within the scope of the warrant. *McCavitt*, 2019 IL App (3d) 170830 ¶ 21.
- 12. There have been several Supreme Court cases which have dealt with this precise issue. In Silverthorne Lumber Co., after federal agents unlawfully seized papers belonging to the Silverthornes and to their lumber company, the documents were returned upon order of the court. In the interim, however, the agents copied the unlawfully seized papers. The agents then tried to use the copied evidence to further their investigation. On those facts, the Court held that the Government is barred from "reaping any fruits from its forbidden act" and further stated that "[t]he essence of a provision forbidding the acquisition of evidence in a certain way is that not merely evidence so acquired shall not be used before the Court but that it shall not be used at all." Silverthorne Lumber Co., Inc. v. United States, 251 U.S. 385 (1920). Defendant is entitled to the return or, in the alternative, the destruction of all

electronic and paper copies made of any of his or his companies' documents that were seized outside the scope of the warrants because the State is not lawfully allowed to retain them for use against a co-defendant.

- 13. A more recent case provides additional guidance on this issue, in *People v. McCavitt*, the Illinois State Police had a valid search warrant to search and seize the hard drive of McCavitt's computer, and during that seizure, police caused that hard drive to be copied. *People v. McCavitt*, 2019 IL App (3d) 170830. McCavitt was charged and acquitted of sexual assault charges based on the evidence found on the copied hard drive. *Id.* at ¶ 5. On the day of his acquittal, McCavitt made an oral request for the return of his property, which was denied with the trial court stating that the property would be returned when things had "cooled down". *Id.* McCavitt filed a written motion for the return of property soon after that the Court never ruled upon. *Id.* The local police department then used the contents of that copied hard drive to charge McCavitt on child pornography charges without procuring an additional warrant. *Id.* ¶ 7. The Illinois Appellate Court ruled that the police were required to examine the contents of McCavitt's mirrored hard drive and *retain only those files that fit within the scope of the warrant. Id.* at ¶ 25. McCavitt's conviction was reversed and his case remanded. *Id.*
- 14. By way of further analysis of how other states deal with the same issue, *McCavitt* cited the following 2016 New York Supreme Court case which stated as follows:

When a warrant is issued which authorizes a search of paper records, the government is entitled to search the files and seize responsive material. They are not permitted to search the files, seize responsive material and then retain files they have never identified as relevant for multiple years, because, at some later time, they might want to search the files again. A search warrant which authorizes a search of voluminous digital records is no different. As Defendant's counsel during an argument pointed out, overseizure is 'a courtesy that was developed for law enforcement.' It is not

a license for the government to retain tens of thousands of a defendant's non-relevant personal communications to review and study at their leisure for years on end.

People v. Thompson, 28 N.Y.S.3d 237, 258-59 (Sup. Ct. 2016).

- 15. In bringing this motion, Defendant is not attempting to assert vicariously the rights of his co-defendants. Defendant is merely insisting on adherence to the basic principle that victims of unconstitutional practices are entitled to effective remedies. In this case, allowing the State to violate Defendant's constitutional protections against unreasonable search and seizure and then rewarding the State by allowing them to maintain copies of those illegally seized records flies in the face of well-established constitutional laws.
- 16. Where federally protected rights have been invaded, courts will be alert to adjust their remedies so as to grant the necessary relief. *Bell v. Hood*, 327 U.S. 678, 684 (1946). Because any co-defendant in this case will lack standing to challenge the use of the illegally seized evidence against them, ordering the return and destruction of any copies that the State made of the illegally seized evidence is the necessary remedy to neutralize the prosecutorial reward for violating Defendant's rights. The Supreme Court has stated that "when a court assists the Government in extracting fruits from the victims of its lawless searches, it degrades the integrity of the judicial system. *Gelbard v. United States United States v. Egan*, 408 U.S. 41, 67 (1972).
- 17. Allowing the State to maintain illegally seized records for use against other co-defendants is rewarding the State for these illegal behaviors. It is this exact behavior that the U.S. Supreme Court has cautioned against many times for more than a century. "The tendency of those who execute the criminal laws to obtain conviction by means of unlawful seizures ... is not to be sanctioned by the courts which are charged at all times with support of the

Constitution." Weeks v. United States, 232 U.S. 383, 383 (1914). Allowing the State to maintain possession of copies of illegally seized evidence also contradicts established Illinois caselaw, as discussed above in McCavitt.

- II. If the State is Allowed to Retain Copies of the Illegally Seized Evidence, Defendant has no Guarantees or Protections that this Illegally Seized Evidence will not be Used against Him at a Trial
- 18. Upon information and belief, the State has not disclosed any of the illegally seized evidence to any co-defendant's in discovery. The State cannot possibly know if the illegally seized material is relevant evidence against a co-defendant, as the State maintains that they have not reviewed any of the material that was outside the scope of the warrants. For the State's argument to succeed, the State is placing itself in the position of both using and not using evidence seized outside the scope of a warrant.
- 19. In prior hearings before this Court, both the State and Special Agent Rossiter have represented to the Court that they have not made use of, or even examined, the out of scope documents that were seized. (See a copy of the transcript for the Motion to Suppress Hearing held on October 25, 2018, attached as Exhibit 1)
 - a. "21:9-14: Q: What did you do with them once you determined they were outside the scope of the warrant? A: They were set aside. If they were file folders with documents outside the scope inside a box that had documents inside the scope of the warrant they were left in that box and never used."
 - b. 21:22-22:1: "Q: If there were documents in those boxes that were from outside the scope of the warrant that was issued, did you utilize those resources or those documents? A: No."

- 20. Special Agent Rossiter also testified in later proceedings that he and his team compiled "ISP working boxes" where they would move records that they often referred to in their investigation into the working box from its original box. When Defense counsel presented at Pontiac to retrieve the illegally seized records, Special Agent Rossiter pulled several files that were outside the scope of the warrants, with dates as early as 2008, from the "ISP working boxes." This definitively shows that the Illinois State Police were examining and making use of illegally seized documents in their investigation. Allowing them to maintain electronic copies of these documents only facilitates a further violation of Defendant's rights.
- 21. Furthermore, this Court has held that the illegally seized out of scope documents cannot be used against Defendant. However, if the State is allowed to utilize these documents in the prosecution of the co-defendants and uses said documents to persuade or convince the remaining co-defendant(s) to cooperate and testify against Defendant, then these documents have been used against Defendant.

WHEREFORE the Defendant, JOHN Y. BUTLER, prays that the Court reconsider its March 6, 2020 ruling on Defendant's *Motion To Return, Expunge, or Destroy All Electronic Copies of Out of Scope Pontiac Records*, and enter an order directing the State to return all electronic copies of the documents listed in Exhibit 1 of Defendant's *Motion To Return, Expunge, or Destroy All Electronic Copies of Out of Scope Pontiac Records*, or directing the State to expunge or destroy all electronic copies of the documents, and for such other relief deemed just and appropriate



<u>DEFENDANT'S RESPONSE TO STATE'S</u> <u>MOTION FOR DISCOVERY SANCTIONS</u>

NOW COMES the Defendant, JOHN Y. BUTLER, by and through his attorneys, J. Steven Beckett of Beckett Law Office, P.C. and Tristan Bullington of Meyer Capel, P.C., and in support of his *Response to State's Motion for Discovery Sanctions* states as follows:

Procedural Background

- 1. On December 21 and 22, 2016, the Illinois State Police ("ISP") executed two search warrants on Striegel Knobloch and Defendant's ABC Storage unit, removing more than 61 boxes of Defendant's business records.
- 2. Defendant and his counsel attempted to coordinate a review the Defendant's own records stored at Pontiac on May 9 and 10, 2018. On the night of May 8, 2018, Defense counsel was informed by the ISP that Defendant was not allowed access to the records and the visit was cancelled.
- 3. On May 16, 2018, Defendant filed a Motion to Compel the State to allow Defendant access to the records that they seized on December 21 and 22, 2016.
- 4. On October 11, 2018, Defendant filed his Motion to Suppress, arguing that the Illinois State Police ("ISP") Search Warrant for Defendant's ABC Storage unit was a general warrant and that it must be suppressed and all of the seized records must be returned.

- 5. On October 24, 2018, a hearing on Defendant's Motion to Suppress was held.
- 6. On October 30, 2018, Defendant filed his Argument on Defendant's Motion to Suppress.
- 7. On November 15, 2018, Defendant filed his Motion to Reopen Suppression Hearing Proofs.
- 8. On December 20, 2018, the State was informally ordered by the Court to produce scanned, electronic copies of the records that were seized pursuant to the ABC Storage Search Warrant.
- 9. It was not until approximately May 29, 2019 that the State produced a completed inventory of the contents of the boxes that ISP seized pursuant to the ABC Storage Search Warrant.
- 10. On December 30, 2019, the Court denied Defendant's Motion to Suppress and Supplemental Motion to Suppress, but ruled that any evidence seized outside the scope of the warrant could not be used by the State.
- 11. On January 8, 2020, after Defendant objected to the State's continued possession of documents that were seized outside the scope of the warrant, the Court entered an agreed order allowing Defense Counsel to, at Defendant's cost, remove any and all out of scope documents seized pursuant to the ABC Storage Search Warrant and the Striegel Knobloch Warrant from the State's possession.
- 12. On January 29, 2020, Defense Counsel met with representatives from the ISP, the Illinois Department of Revenue, and the State's Attorney's Office at the Headquarters in Pontiac, Illinois. On this date, Defense Counsel was finally allowed to remove thousands of out of scope records from the State's possession.

Defendant's February 28, 2020 Second Supplemental Discovery Response

- 13. The State argues that Defendant did not provide information regarding the statements made by the witnesses disclosed in his response, nor did Defendant state with specificity each witness's last known address.
- 14. After the filing of the State's Motion, Defendant provided the last known address of each of the opinion and reputation witnesses.
- 15. The failure to provide the last known address of each witness was an oversight that Defense corrected once brought to his attention.

Subpoena Duces Tecum Compliance

- 16. As stated in the State's Motion, multiple subpoena *duces tecum* were issued by the grand jury on December 21, 2016 compelling the production of documents from CIAM and BMI Concessions.
- 17. The State neglects to bring to the Court's attention the fact that Defendant was unable to produce those documents in response to the subpoena *duces tecum* because on December 21, 2016 and December 22, 2016, the ISP executed search warrants on Striegel Knobloch and Defendant's ABC Storage unit, respectively. During the execution of these warrants, over 61 boxes of Defendant's business records including those which were responsive to the subpoenas *duces tecum* were seized.
- 18. The ISP maintained possession of these documents until Defense Counsel, at Defendant's own expense, and pursuant to a Court Order, traveled to Pontiac, Illinois and personally sorted through and retrieved the out of scope documents on January 29, 2020.
- 19. The State now questions Defendant's compliance with the 2016 subpoenas. The State, with apparent total sincerity, appears to be questioning whether Defendant complied with

- the subpoenas issued on December 21, 2016 because he failed to tender the documents that the ISP seized on December 21 and 22, 2016.
- 20. To this facetious argument, Defendant can only assure the Court that any records that he could have tendered would have been tendered pursuant to the 2016 subpoenas. Records that have not been in his possession since the early hours of December 22, 2016 would not have been tendered pursuant to the 2016 subpoenas.
- 21. To address the State's unfounded accusation that Defendant did not comply with the 2016 subpoenas because Defense Counsel informed them on February 28, 2020 that Bill Mueller was still searching through boxes, Defendant would remind the State that on December 21, 2016, Bill Mueller was Defendant's attorney. The documents that Bill Mueller seeks currently are documents which are not responsive to the subpoena *duces tecum* and instead are supportive to other defenses Defendant may raise at trial, including Advice of Counsel. Any documents to that effect would have been protected from disclosure under the 2016 subpoenas by attorney-client privilege. It is only now to support an Advice of Counsel defense that Defendant is choosing to waive that privilege.
- 22. Furthermore, this is the first time since December 21, 2016 that the State has taken any affirmative steps to enforce these subpoenas or expressed any concerns regarding Defendant's compliance.

Discovery Compliance

23. The State argues that they have complied with the court rulings and worked to provide all materials to Defendant. It should be noted that the State does not represent to the Court that they *timely* provided all materials to Defendant. Because they did not.

- 24. On December 22, 2016, Defendant's then-counsel informed the State that the ISP had seized multitudinous records beyond the scope of their warrants and demanded their return. Since then, Defendant has worked diligently to seek the return of those documents. It was not until January 29, 2020 three years, one month, and eight days after the first demand for their return that the ISP finally released the out of scope documents that were seized illegally. Only after a Court Order compelling them to do so. (Attached hereto is Exhibit 1, email correspondence from Bill Mueller, dated December 22, 2016)
- 25. Until January 29, 2020, Defendant was unable to properly prepare for trial due to the lack of access to his own documents because of the actions of the State. Without being able to access the illegally seized documents, Defendant has been unable to effectively review his own evidence and formulate his own defense. Defendant has been informing the State of his inability to prepare without the seized documents since as early as May 16, 2018. While Defendant did have scanned copies of these documents at the end of May, 2019, these scans were unorganized, unlabeled, and often times illegible due to scanning errors. Defendant was not able to effectively examine the contents and context of the seized documents through this medium.
- 26. Without being able to effectively review the documents that were illegally seized,

 Defendant was unable to determine what witnesses would aid in his defense, what
 documents would be needed at trial, and what defenses were at his disposal that are
 supported by the evidence.
- 27. Furthermore, since at least May 16,, 2018, the State knew the hardship that failing to return the illegally seized records placed on Defendant's ability to prepare his defense. (See Defendant's Motion to Compel State to Allow Unrestricted Defense Inspection of

Defendant's Documents Seized by Illinois State Police, filed May 16, 2018; Defendant's Argument on Defendant's Motion to Suppress, pg. 15; and Transcript of Rossiter Testimony, attached hereto as Exhibit 2, at 17:10-16). The State has been on notice for almost two years that Defendant needed the illegally seized records to effectively prepare his defense, and they still did not return Defendant's records until Defendant physically collected them himself, pursuant to a Court Order.

- 28. It is now disingenuous of the State to argue that they are prejudiced by the timing of Defendant's disclosure. Defendant made timely disclosure of potential exhibits and potential witnesses within the context of the situation. Less than 30 days after Defendant finally regained possession of his illegally seized documents, he was able to begin to formulate his defense, compile a witness list, and review and tender documents, including documents that the State had illegally prevented Defendant from accessing for three years, one month and eight days.
- 29. The State's claim that Defendant's disclosure occurred "on the eve of trial" is further disingenuous, as the documents were produced 45 days prior to trial, allowing the State more time to review the documents before trial, than Defendant had before disclosing them to the State. The State had access to a large portion of the tendered documents for three years, one month, and eight days longer than Defendant. If the State is truly prejudiced, that situation is of their own making and at no fault of Defendant. Defendant should not be penalized in the form of barring evidence or a delayed trial because the State failed to timely tender to Defendant evidence that the State was on notice Defendant needed to effectively form a defense and had no legal basis to exert control over.

Discovery Violation

- 30. Defendant has made all of the timely disclosures that he was able to make without the full scope of his business records available to him until January 29, 2020. He complied with Illinois Supreme Court Rule 415(b) by promptly notifying the State of additional discovery when he was able to, as evidenced by his multiple discovery disclosures.
- 31. To establish a discovery violation under Illinois Supreme Court Rule 415(g)(i), a party must show that the other "party has failed to comply with an applicable discovery rule or an order issued pursuant thereto." Ill. R. 415(g)(i); People v. Kladis, 403 Ill. App. 3d 99 (Ill. App. 2010). Providing documents to the State at a time that the State finds inconvenient is not a violation, especially given the circumstances of this specific case. This would be the case, even if the inconvenience of the timing were not caused by the State's own actions. The State has not made the appropriate showing to sustain an accusation of a discovery violation.
- 32. If any party has violated discovery, the State has impeded Defendant's investigation of his own case, in violation of Illinois Supreme Court Rule 415(a), which states:

Except as is otherwise provided as to matters not subject to disclosure and protective orders, neither the counsel for the parties nor other prosecution or defense personnel shall advise persons having relevant material or information (except the accused) to refrain from discussing the case with opposing counsel or showing opposing counsel any relevant material, nor shall they otherwise impede opposing counsel's investigation of the case.

(Emphasis added) Illinois Supreme Court Rule 415(a)

33. The State knowingly and intentionally denied Defendant access to records that were illegally seized for three years, one month, and eight days. The State knew that the ISP had seized documents outside the scope of the warrant on the day they were seized in 2016. However, they continued to exercise illegal control over and prevent Defendant access to these records until they were ordered by the Court to return them. To now claim that having

those documents returned to them, in the form of a discovery disclosure 29 days after they

were finally returned to Defendant, is a disingenuous argument, at best.

34. The State should not be allowed to sanctimoniously complain that the discovery that

Defendant was finally able to tender after more than three years of waiting is untimely, and

then disingenuously argue that the Defendant is at fault for the delay and deserving of

sanctions.

35. If not for the State's violation of Illinois Supreme Court Rule 415(a), they would not be in

a position to argue any form of violation on the part of Defendant.

36. Defendant is not at fault for the State's inability to review the tendered discovery in the

timeframe that they themselves set by denying access to Defendant's own records for more

than three years.

37. Defendant objects to resetting the trial date to the August 2020 trial setting. Defendant is

ready to proceed with trial on April 13, 2020.

WHEREFORE the Defendant, JOHN Y. BUTLER, prays that the Court deny the State's

Motion for Discovery Sanctions, and for such other relief deemed just and appropriate

It's just been my, I guess my general practice that when I would use an exhibit and reference it on the record, even if it was just for the purposes of impeachment and not for admission, that I would tender it to the court to incorporate as part of the record. Were the court or counsel more comfortable that it not be retained by the court, I wouldn't have objection to that. That was just done based upon my common practice.

THE COURT: Mr. Beckett?

MR. BECKETT: Well, I'm not sure if it was used for impeachment. I thought it was used to refresh recollection and then he then admitted and had his recollection refreshed and agreed with the statements that counsel was making. So I don't really think it's necessary to complete the record in this case; and as I indicated, I actually represent the

family of the victim in that case, and I'm a little concerned about having that document in a public record other than in the case that is -- that is pending if it's not necessary.

MR. RIGDON: If I could just indicate, I misspoke. It was for purposes of refreshing recollection, not impeachment.

THE COURT: Right, so, it was refreshing recollection. It was not admitted. I don't think it needs to be made a part of the court file. Everything that -- the recollection was refreshed. The witness testified consistent with your questions after the refreshing of the recollection. Again, it wasn't admitted, and so it's going to be returned to counsel.

Mr. Beckett, what do you want to do on the motion to suppress. You've received the State's --

MR. BECKETT: I have and I've reviewed. I am going to want to file a reply, but I would like to present the evidence as long as we're in court here today that's consistent with our motion.

THE COURT: I think that's fair. Why don't we proceed with the evidentiary piece. I won't rule today. I'll wait for your reply, and then we'll see where that leaves us. So let's move forward with the motion.

8	DIRECT EXAMINATION BY MR. BECKETT:
9	
10	Q Would you please state your name for the record?
11	A Special Agent Daniel Rossiter, R-O-S-S-I-T-E-R.
12	Q Agent Rossiter, you're the agent who had
13	responsibility for the investigation that led to the
14	indictment and charges in John Butler's case. Is that
15	correct?
16	A Yes, sir, I was the lead case agent.
17	Q Right. And you're with the Illinois State Police.
18	Is that correct?
19	A Yes.
20	Q As part of your investigation, you did utilize search
21	warrants. Is that correct?
22	A Yes.
23	MR. BECKETT: May I have continuing permission to
24	approach, Your Honor?

1 THE COURT: Yes, ves. 2 MR. BECKETT: 3 Q I've handed you what's been marked for identification 4 as exhibit one. Do you agree with me that exhibit one is a 5 search warrant for December 22nd, 2016, for ABC Storage, 6 2442 South Main, Bloomington, Illinois, and storage unit 14 7 leased to John Butler? 8 A Yes, sir. 9 Okay. I want you to look at the second page. 10 presented to Judge Butler at 8:57 a.m. Is that correct? 11 A Yes, sir. 12 And the correct date should be December 22nd, right, 13 not December 21st? 14 Yes, that's correct. 15 So that's a scrivener's error, would you agree? A Yes, sir. 16 Now, under this warrant, you were commanded to search 17 18 and seize documents related to Central Illinois Arena 19 Management, business documents, CIAM and BMI Concessions 20 business documents, correct? 21 A Yes, sir. 22 And that was for a period from January 1, 2013, to March 31, 2016. Is that correct? 23 24 A Yes.

1 And so would I be correct that any document that was 2 outside the date -- those dates of the parameter would be 3 beyond the scope of the warrant? 4 A Yes, that's correct. 5 Did you go to ABC Storage on December 22nd, 2016, at 9:38 in the morning? 6 7 Α Yes. 8 Did you have others with you? 9 Α Yes, there were multiple agents there to assist. 10 Okay. How many? Q 11 Approximately five to six other agents. 12 Okay. Describe the -- the storage facility. 13 It's an open-air facility, meaning there is a 14 manager's office and then behind that building are storage 15 units established in rows with garage doors that are open to 16 the elements. And did you go to unit 14? 17 18 Yes. Α 19 Did you have the door opened or open it yourself? 20 We opened it ourselves with a bolt cutter. The lock 21 on the unit was not from the storage unit. 22 Did you find a table inside the unit? 23 Yes. Α

And so how long were you actually at the unit

executing the warrant?

A I couldn't say exactly how long, long enough to load the boxes out of the unit into various vehicles to transport to a secure facility.

Q All right. Is that what you did at the unit, load boxes from the unit into vehicles to take to another location?

A Yes.

Q And so am I correct that you made no effort to inventory or examine the boxes at the unit?

A Well, at first approach of the unit once the doors were open we saw the card table that was positioned directly in front of the door. There were several boxes on that table with various documents that were inside the boxes as well as out. So we made a decision instead of sitting on site at the storage unit to take them back to the secure facility, state-police-secure facility, to go through and determine what documents were inside the scope of the warrant and which ones were not.

Q Okay. So the state police facility where you were going to take these documents to review them, was that in Pontiac, Illinois?

A No, it was in Bloomington.

Q All right. And how long were you at that location

with those boxes?

A Well, those boxes remained there for a significant period of time.

- Q What is that? What's a significant period of time?
- A A good majority of the investigation, six months.
- Q So, when were they moved from Bloomington to Pontiac?
- A I don't recall a specific date. Once the -- once the boxes or, excuse me, once the documents were -- the quick reference of those documents were no longer needed at arm's length, they were moved to the vault at Pontiac.
 - Q Are we talking months or weeks?
- A Multiple -- I mean several months ago. At least a year ago they've been in Pontiac from today's date.
- Q At the defendant's arraignment he received some discovery with a report, with a notation on the pleading that he could make -- he could inspect the documents at Pontiac.

 Do you recall that?
 - A Yes, sir.
 - Q All right. That was in September of last year.
- A Yes, I believe that that date --
- Q So in relation to that date, when were they taken to Pontiac?
 - A Three to six months prior to that date.
- 24 Q All right. On December 22nd, 2016, after 9:38 a.m.

at the facility did you determine that any of the boxes or their contents were beyond the authority of the warrant?

- A At the storage unit?
- Q At the facility.

- A No, it would have been impossible for us to determine that at the time.
 - Q Well, you would have had to look inside the boxes?
- A Yes, we would have had to have looked at every single file folder inside 61 plus boxes in that unit to determine which were necessary to leave behind.
- Q Okay. At some point in time you determined 27 boxes were outside the scope of the warrant?
 - A Yes, that's correct.
 - O When was that?
- A Once the warrant was executed, we seized all those boxes. We loaded them up. We took them to a secure, covert facility for the Illinois State Police. We then started itemizing or putting the boxes in date order, and then as we went along we began to go through the boxes. Those -- many of those boxes had black Sharpie marker --
- Q That's not my question. My question is when, not how you determined. When did you determine that you had 27 boxes that were beyond the scope of the warrant?
- A I couldn't tell you a specific date of exactly when.

I mean it was a long process going through each box and each document to determine what was and what was not inside the scope of the warrant.

Q How about a date when you first realized that you had a box that was beyond the scope of the warrant?

A Within an hour of being at the secure facility.

There were boxes that were labeled 2009. We opened the box.

We see that the documents in there are, in fact, from 2009,

and that box was immediately set to the side.

Q But these 27 boxes, when did you first realize that you had a box that eventually added up to 27 boxes that were beyond the scope of the warrant?

A Again, I would say that the first box that we decided was outside the scope of the warrant would have been the day the warrant was executed.

Q Okay. Now, prior to your execution of this warrant, you knew that Mr. Butler had a representative that you could communicate with?

A Yes, he was represented by legal counsel. That's correct.

- O William Mueller?
- A Yes, sir.

Q When did you first contact William Mueller and tell him that you had seized documents beyond the authority of the

warrant?

.3

A I know I made notice of the warrant later that day.

Once we had unloaded everything at the secure facility, I

went to his office and gave him a copy of the warrant. I

know I had correspondence with him, as well as Mr. Kording,

that we did have boxes outside the scope and to arrange

return of those boxes.

- Q Right. That was after September 2016, right, or '17?
- A With Mr. Beckett, yes. I don't recall when I spoke to Mr. Mueller about it.
- Q So is it your testimony that you told Mr. Mueller that you had -- before September 2017 that you had documents outside the scope of the warrant that would be returned?
 - A Yes.
 - Q And how was it you were going to return them?
- A That was undetermined at that time.
 - Q Okay. Did you feel you had authority to hold on to those boxes?

A You know, once the search warrant return was complete, once we identified what boxes we felt were evidentiary, yes, I felt that there -- I don't have the authority to return those boxes. However, based on the warrant and based on the fact that we identified I believe you said 24, 27 boxes, were outside the scope, I felt that I

did have the authority to return those boxes to Mr. Butler.

Q Okay, that really wasn't my question. My question was that you had authority to retain them.

A Well, so, the -- yes, I did. I believe that I had the authority to hold on to them until I could confirm that every document in those boxes were, in fact, outside the of scope of the warrant. Some boxes that we retrieved in fact had lids on them that said 2010, and yet they were all documents from 2014. So until we were able to thoroughly go through every single box, I couldn't say if all of the boxes that we obtained were in or outside the scope of the warrant.

- Q But you did determine there were 27 boxes that were outside the scope of the warrant?
 - A Yes.

- Q Did you return them?
- A I attempted to return them through Mr. Beckett.
 - Q No, Mr. Kording. I'm Beckett.
- 18 A Yes, I apologize.
- 19 Q We're fungible.
 - A There was e-mail correspondence with Mr. Kording. A date was arranged for him to come get them in Pontiac. That arrangement fell apart, and there has been no other correspondence as far as getting those documents back to him.
- Q In fact, the date to be arranged in Pontiac was for

the entire defense team and the defendant to come and examine the boxes where they sat, right?

A Yes.

- O All of them?
- A Yes, that's correct; and on top of that, those boxes were set aside and were going to be returned that day.
- Q And so the onus would be on the defendant to return the boxes back to Bloomington, Illinois, from which they had been taken?
- A That was the agreement between myself and Mr. Beckett, yes.
- 12 Q I'm Mr. Beckett.
 - A I apologize, Mr. Kording. I'm sorry. I apologize.
 - Q Well, is there -- what's the reason that you couldn't have returned the boxes when you determined they were beyond the scope of the warrant to the facility that you had taken them from?
 - A I would say that the end date that we determined these boxes are, in fact, outside the scope is relatively close to the date of warrants being issued for their arrest; and I spoke to Mr. Mueller about it I believe the day Mr. Butler was taken into custody, and it was determined that he was not going to continue representation with Mr. Butler. So I was awaiting to see who his counsel would be named.

- Q As we sit here today, you still have all of the boxes. Is that correct?
 - A Yes, sir.

- Q In the motion to suppress we filed, have you seen it?
- 5 A Yes, sir, I have.
 - Q All right. And the boxes that you that you do say were within the scope of the warrant appear to have documents that are outside the scope of the warrant. Would you agree with that?
 - A Yes, sir.
 - Q All right. So what effort have you made to segregate the documents that are outside the scope of the warrant from the documents that are inside the scope of the warrant?

A Well, the boxes you're referring to actually contain documents inside the scope of the warrant as well as outside, and in order to preserve the evidence as we collected it, we determined or we decided or I chose to keep those documents in the exact same boxes that they were taken from to keep them in their — to keep the integrity of that piece of evidence or that box, that file box filled with those documents.

- Q You could apply for a further warrant, could you not?
- 23 A Yes, sir.
- Q To obtain legal authority to maintain those records?

1 Yes, sir. 2 Did you do that? 3 No, sir, I did not. 4 So, I'm specifically talking about -- let me hand 5 this to you. So I'm starting with this paragraph. just like you to look at that. 6 7 Okay, paragraph six here? 8 Yes. 9 Okay. Α 10 MR. RIGDON: Your Honor, I'm not sure... 11 MR. BECKETT: Paragraph six of the motion to 12 suppress. I've handed him the motion to suppress. 13 Do you agree with the description of the items in 14 paragraph six and thereafter regarding documents that are 15 outside the scope of the warrant? 16 I would agree that your recollection is probably 17 accurate. Without looking at the boxes, I couldn't say, but 18 I will say that, yes, this is probably accurate. 19 THE COURT: Can I ask, because I'm kind of lost 20 here, page six of the motion? 21 MR. BECKETT: Paragraph six, page two. 22 THE COURT: Page two. 23 MR. BECKETT: Through page eight. 24 THE COURT: Okay, thank you.

MR. BECKETT: All right, that's what we're talking about.

- Q And I'm correct what you have done at the direction of the State's Attorney's you've been going through these boxes and you've been scanning documents, correct?
 - A Yes, sir.

- Q And then those have been provided to us so that we could examine what the contents were?
 - A Yes, sir.
- Q Would you agree with me that by you having the boxes they have not been available to Mr. Butler?
- A Yes. Well, the ones that we have determined as evidentiary, yes, that is correct.
 - Q Okay. And the documents in there that I identified in paragraph six, those have not been available to Mr. Butler, correct?
 - A Correct.
 - Q And the 27 boxes are available to Mr. Butler if he makes arrangements to pick them up?
 - A Well, it doesn't have to be arrangements to pick them up. It just has to be an arrangement for transfer of those boxes; however that is facilitated is fine with me. I'm flexible. Part of the reason why it was scheduled for them to pick them up is I felt it would be more convenient since a

large group of attorneys would be there to copy documents to begin with that while they have large vehicles it would be easy to transfer or facilitate the transfer of custody of those boxes that were determined outside the scope of the warrant.

Q You -- you set the parameters, that two-year parameter, that July or January 1, 2013, or three-year parameter, to March 31st --

- A Yes, sir.
- Q -- 2016. That was your parameter, right?
- 11 A Yes, sir.

- Q That's the parameter that you asked the judge to approve in the search warrant?
- A Yes, sir.
 - Q In your complaint for search warrant, you didn't indicate to the judge that you were going to remove the items from that storage facility in the manner you've described, did you?

A Well, we didn't even know if the storage facility would contain documents. We found documentation that suggested or that gave us probable cause to believe that the documents were stored there, but we had no idea what we were going to find once that storage locker was open.

Q Right. But you did -- you agreed with me, you didn't

1 put it in the complaint, the original complaint, correct? 2 Correct. Α 3 Q And you didn't seek some subsequent warrant that 4 would allow you to take all of the boxes regardless of the 5 date scope? 6 A Well, as far as the investigation was concerned, that 7 would have been unnecessary to get another warrant for those documents. They weren't needed. 8 9 Well, you find a cellphone, right? You want to look 10 at the contents, you go get a warrant? 11 A Right, in most cases, yes. 12 Q Okay. So you find these boxes that appear to be 13 beyond the scope of your warrant, you could get another 14 warrant? 15 Α Yes. 16 You didn't do that? 17 A No, it wasn't necessary. 18 MR. BECKETT: That's all the questions I have. THE COURT: Mr. Rigdon? 19 20 21 CROSS EXAMINATION BY MR. RIGDON: 22 23 Q As it relates to the boxes that you seized from the 24 storage unit, we've just generally testified to them as being boxes. Could you describe the boxes a little further as far as size and volume of contents?

A I would say about half and half were legal boxes.

Maybe half of them were the small standard-size legal boxes.

Others were longer than this table here. You know, you're talking about tens of thousands of documents contained within these 61 boxes. Again, there was a table set out at the front of the storage unit. It appeared somebody had been going through the documents. You know, at that point, that's when we decided to move the documents to a further secure location to verify their -- whether they were within the warrant or not at that point.

Q And did, as you may have touched on it during direct, did all of the external labeling on the boxes match the actual internal contents?

A No.

Q And so you had to actually look inside of the boxes one at a time to determine what types of documents were inside of them?

A Yes, that's correct.

Q And you indicated that took place over a significant course of time?

A Yes.

Q Would you have been able to do that at the storage

unit that day?

A No.

Q Through the course of the investigation, let's start with the 27 boxes that you determined could not be within the scope of the warrant. Did you use any of the contents of those warrants in furthering the investigation or those boxes, excuse me, in furthering the investigation?

A No.

Q What did you do with them once you determined they were outside the scope of the warrant?

A They were set aside. If they were file folders with documents outside the scope inside a box that had documents inside the scope of the warrant they were left in that box and never used.

Q And then there is 34 other boxes that were determined to be at least to contain information within the scope of the warrant as far as time frame. Is that correct?

A Yes.

Q And you kept those together in order to maintain the integrity of the entire box as you found it?

A Yes, that's correct.

Q If there were documents in those boxes that were from outside the scope of the warrant that was issued, did you utilize those resources or those documents?

A No.

Q Did you have access -- this warrant for the storage unit was from January 1, 2013, to March 31, 2016. Is that correct?

A Yes.

Q Was your investigation in its entirety limited to only going back to January 1, 2013?

A No.

Q Were there other sources through which you located documents and information that you did use prior to January 1, 2013?

A Yes, several different sources.

Q Were those multiple computers that were searched?

A Yes, multiple computers, also boxes of documents left inside the building of the Coliseum, as well as documents provided through subpoena and, like you said, at least three different computers.

Q As it relates to the 27 boxes that were determined to be outside the scope, if arrangements were made, could those be delivered somewhere to the defendant?

A Yes, they could.

Q Was it ever communicated to him that he had to come pick them up in Pontiac?

A I don't recall if that verbiage was used. I believe

1 it was established that way because Mr. Kording and his legal 2 team were going to be coming up anyway. Q Were they ever -- were they ever asked to have to deliver them to Bloomington on any particular time or date? 5 A Not that I recall. There was -- did you obtain a search warrant in June 7 of 2018 for bank records from CEFCU? 8 Yes. Α 9 Do you have a copy of the motion in front of you 10 still? 11 Yes, I do. 12 I'd ask you maybe to just refer, with Mr. Beckett's 13 consent, I would just ask him to refer to one of the exhibits 14 that was attached there, exhibit number five, which is the 15 last page of that motion. 16 MR. BECKETT: Yes. 17 MR. RIGDON: 18 Q Can you see that? 19 Yes. 20 1 Is that a fair and accurate copy of a search warrant 21 that was obtained in June of 2018? 22 Yes, it is. 23 To attempt to highlight a second scrivener's error,

down on the issue date does it indicate June in 2016?

1	A Yes, it does.
2	Q Was it nonetheless June of 2018 in which it was
3	issued?
4	A Yes.
5	Q Did you use any of the information from any the
6	61 boxes that was outside the scope of the search warrant in
7	making that request?
8	A No.
9	Q Was any of the was any of the information from the
10	boxes outside the scope of the warrants referenced in any way
11	in the complaint?
12	A No.
13	Q Was it, in fact, in part based on analysis of one of
14	the computers that was subject to search?
15	A Yes.
16	MR. RIGDON: Your Honor, I have no other questions
17	for Special Agent Rossiter.
18	THE COURT: Mr. Beckett?
19	
20	REDIRECT EXAMINATION BY MR. BECKETT:
21	
22	Q Agent Rossiter, you indicated that when you were at
23	the warehouse there was a table with boxes, and it looked
24	like someone was going through the boxes. Do you remember

that?

- A Yes, sir.
- Q In fact, on December 21st you had served a subpoena duces tecum to Mr. Mueller, had you not?
 - A Yes, that's correct.
- Q And that subpoena duces tecum asked for BMI Concession documents from January 1, 2013, to March 31, 2016. Is that correct?
 - A Yes.
- Q And so if there were BMI records there, you would expect someone to be working on compliance with that subpoena, wouldn't you?
 - A Yes, sir.
- Q Okay. So you didn't think there was anything untoward about somebody being there in their own warehouse looking at documents?

A Well, I don't want to speculate what somebody could or could not have been doing there. I assumed that and, in fact, one of the other agents with me recognized Mr. Butler leaving the storage area as we were speaking to the management to serve the warrant to them on the grounds. So we had a good idea of who was there and who was sorting through the documents, but the reasoning for that, that would be speculation on my part.

1	Q Well, you had served the subpoena, had you not?
2	A Yes, that's correct.
3	Q I'm handing you what's marked for identification as
4	Defendant's Exhibit Six.
5	A Okay.
6	Q That's the subpoena for BMI Concession records of
7	December 21, 2016, that you had served. Is that correct?
8	A Yes, sir.
9	MR. BECKETT: I move to admit exhibit six.
10	MR. RIGDON: No objection.
11	THE COURT: Without objection, Defendant's Six is
12	admitted.
13	MR. BECKETT: I have no other questions.
14	THE COURT: Anything else, Mr. Rigdon?
15	MR. RIGDON: No thank you, Your Honor.
16	THE COURT: Thank you.
17	THE WITNESS: Thank you, Judge.
18	(Witness excused.)
19	THE COURT: Any additional evidence, Mr. Beckett?
20	MR. BECKETT: No, Your Honor.
21	THE COURT: Anything, Mr. Rigdon?
22	MR. RIGDON: No, Your Honor.
