*if someone gets promoted to a new position, they need to be sworn into that position.

Always remember to put either the date of the appointment or the date of the election on the back side of the Oath form, along with the date the Oath was filed with the Clerk's office.

REMEMBER: Distinguish between elected and appointed positions by indicating if the person has been "appointed to the position" or "elected to the position" on the oath.
