BUDGET IMPACT:

The entire \$79,571.78 expense will be covered by the Town's Energy Efficiency and Conservation Block Grant (EECBG), which was previously awarded by the U.S. Department of Energy. Installation costs are included in the Uptown Station construction budget or will be the paid for by participants in the proposed Town of Normal Charging Station Grant

BACKGROUND

The 2009 American Recovery and Reinvestment Act (ARRA) appropriated funding to the United States Department of Energy that is to be passed along to states and municipalities on a formula basis through the previously created Energy Efficiency and Conservation Block Grant (EECBG) program. The Town of Normal was eligible to receive \$488,500 under this grant program. In May of 2009, the Town Council approved a project list for this grant program and staff subsequently applied for full funding to the Department of Energy. That application was approved and staff is now in the process of implementing the various components of the grant program.

The Department of Energy recently asked the Town to reprogram \$100,000 of the EECBG grant that was previously set aside for an energy efficiency revolving loan fund. This request was due to the fact that no loans had been made in the first year of the program's operation. Town staff has received authorization from the Department of Energy to reprogram these funds under the existing "Fuel Reduction Initiative" category. Specifically, the funds are targeted for additional electric vehicle charging stations and bicycle parking and storage amenities.

In February of 2011, the Council authorized staff to purchase thirty-three (33) charging stations from the Eaton Corporation, via the local Eaton supply company Crescent Electric. These stations have either been installed, are awaiting delivery, or are still pending as final locations are determined. The proposed

quote from Crescent Electric extends the same discounted pricing from Eaton on sixteen (16) additional vunits, including one Level III or DC Quick Charge unit.

DISCUSSION/ANALYSIS

Town staff is finalizing plans for the Town's first thirty-three Level II charging stations. The following is a breakdown of the locations for these initial units:

- City Hall / Police (6 units)
- Fire Station Headquarters (1 unit)
- · Public Works (1 unit)
- College Avenue Parking Deck (3 units)
- Beaufort Street Parking Deck (2 units)
- Illinois State University (4 units)
- City of Bloomington (4 units)
- Illinois Wesleyan University (2 units)
- Heartland Community College (2 units)
- Central Illinois Regional Airport (2 units)
- McLean County (2 units)
- Undetermined (4 units)

The undetermined units will likely be placed in the surface lots surrounding or on the streets of Uptown. Smaller level I units may be used on the street side in order to increase the quantity of available chargers. Other potential locations include the Normal Public Library or a host business to be identified in the proposed Town of Normal Charging Station Grant Program.

The attached quote from Crescent Electric includes sixteen additional charging stations. Staff is proposing that a total of six of these charging stations be placed in the Uptown Station Parking Deck. This includes five Level II and one Level III chargers. The Level III charger will be one of the first installations the nation and will charge a battery up to 80% full in approximately twenty minutes. This high level of service will provide tremendous assurance to electric vehicle owners and will also allow for greater electric vehicle use in the Town fleet.

Currently, the Level III Eaton chargers are made in Japan, while their Level II chargers are manufactured in North Carolina. Due to the federal Buy American law, staff will not be able to order the Eaton Level III charger until it is made in the United States, which Eaton expects will take place in the first quarter of 2012. Should Eaton not be able to provide a Level III charger in this timeframe, staff will come back to Council with additional options for a Level III charger.

Staff is proposing that the remaining ten chargers from the attached quote be distributed to businesses or organizations through a Town of Normal Charging Station Grant Program. This grant program will be modeled after the agreements that Council previously authorized with select governmental and institutional partners (i.e. ISU, IWU, Bloomington, etc). Interested businesses and organizations would apply to the Town of Normal to receive a grant of one or more charging stations. Those entities would agree to pay for installation and to allow for free charging for a five-year period. Staff will evaluate applications and make a determination based on several factors including, but not limited to:

- Diversity of the audience served at the location
- · Number of visitors at the location
- · Geographic location
- Plans for additional electric vehicle accommodations

If Council accepts the quote and authorizes staff to create the grant program, it is expected that awards will be made in January or February with all installations completed in the early spring of 2012. This timeline dovetails with the anticipated arrival of the Mitsubishi "i" electric vehicles.
