  - a. Will/have the COVID-19 impacts impede the project's ability to deliver the intended project benefits?
    - i. *E.g.* were impacts to the project due to higher than anticipated bids as a result of the COVID-19, or lower than anticipated matching funds as a result of COVID-19?

The Town of Normal has experienced revenue losses due to COVID-19 through several sources including local sales tax, hotel tax, food and beverage tax, and state sales tax. Estimated losses were calculated at \$2,188,000 in March 2021 and negative financial impacts are expected for the next few years.

2. Describe how reallocated funds could address the budget shortfalls if awarded.

In additional to revenue losses, inflation increases are expected to impact the cost of the project. Conceptual cost estimates were originally developed in 2019. The Town has included inflation in updated estimates to FRA, however, estimated inflation at that time was 1.54%. As of February 2022, estimated inflation is now at 7.9%. With inflation at higher rates, impacts to the project could be in the order of \$6 million. Estimated project costs are attached.

3. Provide a detailed description of how/whether the existing scope of work could help alleviate supply chain challenges with additional reallocated funds.

Material costs and lead time for orders and delivery are expected to be higher than previously anticipated. Additional funding would support the cost increases and, with known issues on supply chain and delivery schedules, there may be opportunities to place advance orders for materials where appropriate.

4. Provide a detailed description of how/whether the existing scope of work could help combat increased transportation costs.

Transportation of materials, such as the precast concrete segments, are expected to be at higher costs than previously estimated. Labor related to shipment may also be a factor. Increased funding would be beneficial in addressing costs associated with transportation of materials.

5. Describe how/whether the project has made satisfactory progress implementing the current scope.

Final design has been advanced under pre-award authority received from FRA and, most recently, 60% design was submitted to project partners on April 1, 2022. The next project milestone is 90% design, which is planned to be submitted in September 2022.

Based on the current design schedule, construction is expected to begin in spring of 2023 with substantial completion of construction expected by end of 2024.

6. Provide a schedule demonstrating the funds will be obligated prior to the lapse date of September 30, 2022.
